### Key Terms:

**UOCAVA:** The Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) is federal legislation designed to ensure that absent Uniformed Service Members and members of the Merchant Marine, their dependents, and overseas U.S. citizens have adequate opportunity to successfully cast their ballot in federal elections.

**UOCAVA voter:** Members of the Uniformed Services or Merchant Marine who are absent from their voting jurisdiction due to their service. Spouses and dependents of members of the Uniformed Services or Merchant Marine who are absent from their voting jurisdiction as well as U.S. citizens residing outside the United States and its territories.

**non-UOCAVA voter:** For this report, a non-UOCAVA voter is defined as any voter who votes absentee. These voters are not covered by UOCAVA. This does not include those who vote in person before election day.

**FPCA:** The Federal Post Card Application (FPCA) form that UOCAVA voters use to simultaneously apply to register to vote and request an absentee ballot.

**non-FPCA:** This is a form used by voters to register and/or request an absentee ballot, other than the FPCA. Examples include: the State voter registration form, the State absentee ballot application, National Mail Voter Registration Form, etc.

**E45:** This is the ballot transmission deadline for UOCAVA ballots as stated in the UOCAVA. For this report, "E" is the election day and the number is the days before the election.
