Two North Carolina Special Elections Scheduled *Register now and request your absentee ballots at FVAP.gov*

Alexandria, VA – Ballots are currently available for two special primary elections in the State of North Carolina to fill vacancies in the 3rd and 9th Congressional Districts.

The special primary election in the 3rd Congressional District will be held on April 30, 2019. This District includes all or part of Beaufort, Camden, Carteret, Chowan, Craven, Currituck, Dare, Greene, Hyde, Jones, Lenoir, Onslow, Pamlico, Pasquotank, Perquimans, Pitt, and Tyrrell counties.

The special primary election in the 9th Congressional District will be held on May 14, 2019. This District includes all or part of Anson, Bladen, Cumberland, Mecklenburg, Richmond, Robeson, Scotland and Union counties.

Service members, eligible family members and overseas citizens who are residents of North Carolina's 3rd or 9th Congressional districts, should register and request an absentee ballot today at FVAP.gov using the Federal Post Card Application (FPCA). Complete, sign and send the FPCA to your election office.

To access the FPCA, you can:

- Use the FPCA online assistant (fvap.gov/r3/fpca/state?state=NC); or
- Complete the fillable PDF version (fvap.gov/uploads/FVAP/Forms/fpca.pdf); or
- Pick up a hardcopy version from your Voting Assistance Officer or nearest U.S. Embassy or Consular Office

Be sure to double-check that your contact information is accurate in case your election office needs to reach you to ensure you receive your ballot.

If you have not received your requested State ballot 30 days before the election, use the backup ballot, or Federal Write-In Absentee Ballot (FWAB). It's available at www.fvap.gov/r3/fwab/state?state=NC via an online assistant that provides you with the candidate list. You may also complete the fillable PDF (fvap.gov/uploads/FVAP/Forms/fwab.pdf) or pick up a hardcopy version from your Voting Assistance Officer or nearest U.S. Embassy or Consulate.

If you receive your State ballot after submitting the FWAB, you should still complete and return it, as well. Only one ballot per person will be counted.

- Voter Registration: May 13, 2019, 5:00 PM ET
- Ballot Request May 13, 2019, 5:00 PM ET
- Ballot Return via Email/Online or Fax: 7:30 PM ET on May 14, 2019
- Ballot Return via Mail: Sent by May 14, 2019 and received by 5:00 PM ET on May 23, 2019
