## FVAP Publishes 2018 Absentee Voting Procedures for Military and Overseas Voters

Updated on 11/3/2017 to reflect that hard copies of the published Guide will be distributed to VAOs in December 2017. This release originally indicated they would be distributed in December 2018.

ALEXANDRIA, Va. – FVAP is pleased to announce the release of the 2018-2019 Voting Assistance Guide (Guide) with updated content for the 2018 General Election cycle. FVAP publishes the Guide for use by voters, military and State Department Voting Assistance Officers (VAOs), overseas citizen organizations and election officials.

The Guide is a state-specific compendium of absentee voting regulations, rules, and deadlines across all 50 States, the District of Columbia, and the four U.S. territories covered under the *Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA)*. It also includes the procedures that military and overseas voters must follow to successfully register to vote and cast a ballot using the Federal Post Card Application and Federal Write-In Absentee Ballot.

The Guide is a critical resource for Voting Assistance Officers (VAO) worldwide to help voters complete the absentee voting process. The new information has also been incorporated into FVAP.gov and can be found by selecting a State from the drop-down under "Voters Start Here" or at https://www.fvap.gov/vao/vag.
