

GUIDE COORDINATION REMINDERS FOR STATE ELECTION OFFICIALS

We appreciate the time and effort you have put in to the 2020-2021 Voting Assistance Guide Coordination. Having the most up-to-date information for your voters is crucial in their ability to submit FPCAs and ballots from the military or overseas. Most importantly, FVAP relies upon this information for both its website content and its hard copy versions of the guide used by our Voting Assistance Officers throughout all of the Military Services. The second coordination is still ongoing and will conclude on Friday July 12th, 2019. Final coordination will begin later this summer. Let's continue to work together to support our military, their families and overseas citizens around the world.

REPORT TO CONGRESS 2018 ELECTION CYCLE REPORT

FVAP's 2018 Report to Congress will be delivered to the Hill on July 31st to report on the activities and findings of FVAP during the 2018 election cycle. After each general election, FVAP is required to conduct a statistical analysis on voter registration and participation rates for our military and overseas citizens along with an overall report on program effectiveness. It will be available to read on FVAP.gov upon its transmittal to Congress.


NATIONAL ASSOCIATION OF STATE ELECTION DIRECTORS (NASED) CONFERENCE

BEST PRACTICE: POSTAGE PAID INDICIA

As the 2020 election cycle revs up, start working with your mail piece design analysts at your post offices to prepare the postage paid ballot return envelopes and gather answers to any of your election mail design requirements. They can help you to ensure the proper usage of the postage paid indicia by assisting you with the domestic mail manual and help reconcile USPS design requirements. Our partners at USPS provide all the information you need to prepare for the 2020 cycle through their official election mail kit including a listing of election mail coordinators for your jurisdiction to work with:

Now is also the time to start thinking about UOCAVA list maintenance efforts ahead of the Presidential Preference Primary elections. This is a great way to have your military and overseas citizens update their address information by sending a new Federal Post Card Application in the mail and have them resubmit for the 2020 calendar year.
